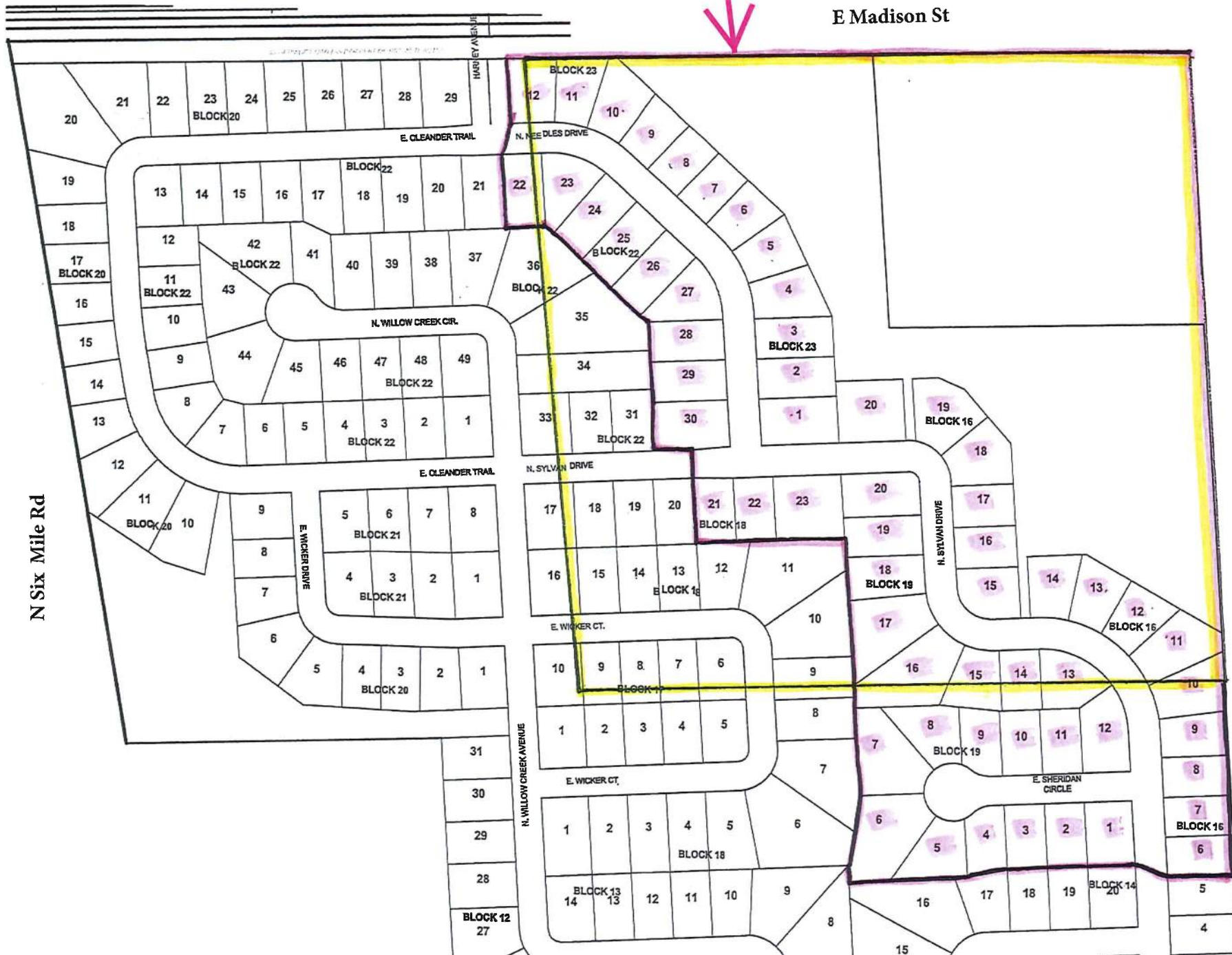


Yellow = Existing Xcel Energy Territory Boundary

New Proposed Xcel Energy Territory Boundary Description:

1. BEGINNING at the NW corner of Lot 12 Block 23 in Willow Ridge Addition to the City of Sioux Falls in Section 17 of Township 101 North (T101N), Range 48 West (R48W), Minnehaha County,
2. THENCE continue south to the SW corner of Lot 12 Block 23,
3. THENCE continue southwest to the NW corner of Lot 22 Block 22,
4. THENCE continue south to the SW corner of Lot 22 Block 22,
5. THENCE continue east to the SE corner of Lot 22 Block 22,
6. THENCE continue southeast to the NW corner of Lot 28 Block 22,
7. THENCE continue south to the SW corner of Lot 30 Block 22,
8. THENCE continue east to the midway point of the S side of Lot 30 Block 22,
9. THENCE continue south to the SW corner of Lot 21 Block 18,
10. THENCE continue east to the midway point of the W side of Lot 19 Block 19,
11. THENCE continue south to the SW corner of Lot 7 Block 19,
12. THENCE continue southwest to the NE corner of Lot 9 Block 13,
13. THENCE continue south to the SW corner of Lot 6 Block 19,
14. THENCE continue east to the NE corner of Lot 16 Block 14,
15. THENCE continue northeast to the SW corner of Lot 3 Block 19,
16. THENCE continue east to the SE corner of Lot 1 Block 19,
17. THENCE continue southeast to the SW corner of Lot 6 Block 16,
18. THENCE continue east to the SE corner of Lot 6 Block 16
19. THENCE continue north to the NE corner of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 17 of T101N, R48W,
20. THENCE continue west ENDING at the NW corner of Lot 12 Block 23 in Willow Ridge Addition to the City of Sioux Falls in Section 17 of Township 101 North (T101N), Range 48 West (R48W), Minnehaha County.
