**RE: REVISED SERVICE TERRITORY FOR THE CITY OF

Please consider this letter as an application for an amended Certificate of Authority for local exchange service pursuant to SDCL 49-31-69.

Enclosed is a Revised Franchise Service Territory Map reflecting the new telephone service territory as a result of annexation of land by the City of Brookings (See Attachment 1). Also enclosed is a copy of the City of Brookings Resolutions No. 25-053, No. 25-041 and No. 22-103.

A full range of local exchange services will be provided which is identical to the exchange services provided to all residents of the City of Brookings.
